A) RFQ Process

- 1. Offers must be submitted to procurement@omantowerco.om before the submission deadline.
- 2. Clarification queries must be submitted to the same email address at least 1 working days before the bid submission deadline.
- 3. Offers must be valid for at least 30 days.
- 4. This RFQ, content and any corresponding information shall be considered Confidential Information under the NDA which shall be signed and stamped and shared by the bidder upon receiving the RFQ.
- 5. Contract will be awarded for One years.
- 6. This RFQ does not commit OTC to award any Work.
- 7. The bidder shall provide a commercial proposal in breakdown as stated in Page 03.
- 8. Oman Tower at its discretion is not bound to award to the lowest bidder.
- 9. This RFQ does not commit OTC to award any work.
- 10. The bidder who will be awarded shall pay a registration fee; this is only applicable to unregistered bidders.

A) Scope of Work:

- Oman Tower Company is requesting the supply of 50 sq.mm insulated aluminum power cable. This cable will be used to equipment earthing at telecom tower sites.
- The cables shall be delivered to Muscat (custom duty paid), to a warehouse designated by OTC.



B) Evaluation Criteria:

Technical evaluation

• Technical Evaluation: The cable must be compliant with applicable electrical standards in Oman for a use as power cable.

Commercial evaluation

• Commercial Evaluation: Award to the lowest compliant bidder, subject to delivery time, minimum purchase quantity and payment terms being reasonable.

C) SCHEDULE OF PRICE:

The bidder shall fill and submit the schedule of price covering the scope of work within the proposal:
